## **DESCRIPTION OF BUILDING PRODUCT**

SoundDown Pre-Assembled Battens (PAB) are acoustic battens manufactured from LVL timber and recycled rubber isolation strips (42 mm x 46 mm). They are available in 3 m lengths.

The battens' contribution to acoustic performance has been established when incorporated into the SoundDown PAB system refer SoundDown Mass Timber Design & Installation Guide V2.8 although the battens may also be used in other acoustic assemblies.

Where installed in an alternative assembly, acoustic performance must be determined based on the assembly in its entirety.

## CONTRIBUTION TO BUILDING WORK CODE OBLIGATIONS

When used in building work the Soundown PAB batten will contribute to building work through compliance with building code obligations that apply to the product itself.

B2 (Durability) B2.3.1 (a), B2.3.2 (a)	Untreated timber provided for in NZS3602 (refer table 1E.5). Rubber isolation strips will have no less a durability than LVL timber since it won't be exposed to any environmental conditions that would cause changes the material.
